FOURTH CIVIL CIRCUIT COURT OF THE FIRST JUDICIAL CIRCUIT OF PANAMA. Panama, this thirty-first (31<sup>st</sup>) day of August, two thousand and six (2006).

ORDER No. 1227-2006

HAVING SEEN:

The law firm of INFANTE & PEREZ ALMILLANO, judicial attorneys-in-fact of HILDA PIZA LUCOM or HILDA ANTONIA PIZA BLONDET, have asked this Court for a General Protection or Conservation Measure in favor of its constituent and against RICHARD SAM LEHMAN.

It should be pointed out that this Court, in Order No. 1025/173-06 of July 5, 2006, appointed Mr. RICHARD CHARLES LEHMAN executor in the probate proceedings of the testate estate of the late WILSON CHARLES LUCOM pending before this court.

Said decision was appealed from by JOSE SALVADOR MUÑOZ, Esq., judicial attorney-in-fact of Mrs. HILDA P. LUCOM, said appeal having been granted essentially with devolutive (or returnable) effect; subsequently, and abiding by the provisions of Article 1129 of the Judicial Code, the Court officially revoked said decision through Order No. , the appeal being granted with deferred effect.

The above means that the decision appointing Mr. RICHARD CHARLES LEHMAN as executor of the will has not been registered inasmuch as it is under appeal and, therefore, it is not final.

Order No. 1219-2006/82s-06 of August 29, 2006, admitted the present protective measure, setting a bond of B/. 1,000.00 for the exercise thereof.

The plaintiff's judicial attorneys-in-fact filed with the Court, through Pleading No. 99 of August 30, 2006, a Guarantee Certificate issued by Banco Nacional de Panamá, No. 0113336, paid in cash, and therefore, the request should be heeded and the protective measure requested should be ordered.

Therefore, the undersigned **FOURTH CIVIL CIRCUIT JUDGE OF THE FIRST JUDICIAL CIRCUIT OF PANAMA**, administering justice in the name of the Republic, and under the authority of law, **ORDERS A GENERAL PROTECTION OR CONSERVATION MEASURE** in favor of **HILDA PIZA LUCOM** or **HILDA ANTONIA PIZA BLONDET** against **RICHARD SAM LEHMAN**, the bearer of passport L 550-757-44-081-0, consisting of the following:

[ ] **PREVENTING RICHARD SAM LEHMAN**, the bearer of passport L 550-757-44-081-0, availing himself of his designation as executor of the will in the estate of the late **WILSON CHARLES LUCOM** from performing acts of administration, establishment of liens, or any acts of disposition of the property of the testator, to wit:

3. Joint checking account No. 03-01-01-021234 with Banco General, S.A.;

7. Checking account No. 01-20-5957 with Bienvivienda, S.A.;

9. Real property No. 3008, volume 345, folio 500, updated to digital document No. 126071, of the property section of the Public Registry, Province of Panama, owned by HACIENDA SANTA MONICA, S.A.;



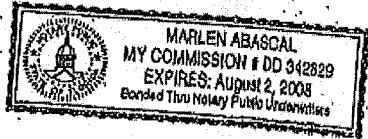
